# **ANS Conference in Salt Lake City**

The 2018 American Name Society Conference was held in conjunction with the Linguistic Society of America at the Grand American Hotel in Salt Lake City from January 4-7, 2018. The Grand American Hotel was the perfect venue for the 2018 ANS Conference. The hotel truly lived up to its name and the conference exceeded expectations. Thirteen panels and two keynote addresses were featured.

Around forty participants, including linguists, onomasticians, and names enthusiasts, met at the conference to share their knowledge and fascination with names and naming practices. Participants hailed from Kuwait, the Republic of Korea, Italy, Germany, Switzerland, South Africa, Sweden, and various regions of the United States.

Panel sessions were held in the elegant Versailles and Belvedere rooms at the Grand American Hotel. Sessions were organized around the following onomastic topics: name changes, names in the news, indigenous names and names in the work place. In addition to these individual papers, the conference also featured two excellent guest lectures. The first keynote presentation was held by Mr. Van Celaya of the Family History Library in SLC spoke about "Fast, Accurate Research for Family History." Celaya provided the audience with useful information about conducting their own genealogical searches, and he demonstrated the process. Audience participation enhanced his congenial keynote.

In the second keynote presentation, environmental biologist Dr. Jeff Yule of Dixie State University, spoke on "Naming Extinction Events and Navigating Extinction Borders." Dr. Yule's address covered such topics as deextinction and rewilding. Drawing examples from scientific literature, popular non-fiction, fiction, and film, Dr. Yule showed how extinction events are named, noting that the process "exerts a significant influence on how we do—and don't—address extinction." In addition to papers and keynote presentations, two ANS executive council meetings and the

annual business meeting\* were held. A highlight of the conference was the celebratory banquet at Squatters restaurant in downtown Salt Lake City. Here, participants dined in a convivial atmosphere, enjoying fine food and finer company.

The award for the best article in *Names: A Journal of Onomastics* was established in 2009. The honor is given to a piece judged to have the highest academic achievement in the field of onomastics.


The 2017 Award Committee for Best Article in *Names: A Journal of Onomastics* consisted of the following individuals:



## Naming, Identity, and Tourism (NIT) Conference

An international conference on Naming, Identity, and Tourism, sponsored by the University of Basilicata, Potenza, Italy was held from May 3-5, 2018. ANS Secretary Luisa Caiazzo served on the conference committee and helped organize the conference events. Attendees hailed from Albania, Belgium, England, Hungary, Israel, Italy, and the United States.

The first day of the conference was held on the beautiful campus of the University. Presentation topics included extinction tourism, tourist-inspired rebranding, railway heritage tourism, and toponyms and tourism.

Another special event was a concert presented by the University of Basilicata Choir. The musical selections ranged from an aria by J.S. Bach to an Alleluia Madrigal by D. Moore.

On the second day of the conference, the location shifted to the National Archeological Museum of Basilicata.

In this historic building, amidst a fascinating collection of antiquities, participants heard presentations ranging from Maori ecotourism and naming to Tanzanian heritage tourism. Other topics covered that day included information about the digital database of the Hungarian National Toponymy Registry and an explanation of Romanization systems, tourism and national identity. A private tour of the museum was also made available to attendees.

On the third day of the conference, participants took a field trip to the ancient, but vital, city of Matera, that will be the 2019 European Capital of Culture. The Sassi and the Park of the Rupestrian Churches of Matera—a complex of houses, churches, monasteries and hermitages built into the natural caves of the Murgia—has been in the UNESCO World Heritage List since 1993.
