# Call for Nominations for 2022 Names of the Year

The American Name Society requests nominations for the "Names of the Year for 2022." The names selected will be ones that best illustrate, through their creation and/or use during the past 12 months, important trends in the culture of the United States. It is not necessary, however, for a nominated name to have originated in the US. Any name can be nominated as long as it has been prominent in US American discourse during the past year.

Nominations are called for the following categories:

• **Personal Names**: Names of individuals or groups of people.

- Place Names: Names of geographical locations, including all natural features, political subdivisions, streets, and buildings.
- Trade Names: Names of commercial products, non-profit companies, and other companies, organizations, and businesses.
- Artistic & Literary Names: Titles of art works, books, plays, television programs, movies, etc.
- E-Names: Names of persons, figures, places, products, businesses, institutions, operations, organizations, platforms, and movements that exist in the virtual world.
- **Miscellaneous Names**: Names that do not fit in the above five categories.

Winners will be chosen in each category, and then a final vote will determine the overall Name of the Year for 2022. Anyone may nominate a name. All ANS members attending the annual meeting in January 2023 will select the winner from among the nominees.

# **Slate of New ANS Officers**

Unfortunately, despite an intensive search and multiple inquiries of well-established ANS members, we have been unable to find a suitable candidate for the VP post. For that reason, ANS President Laurel Sutton and Past President Iman Nick proposed a two-part contingency plan to the ANS-EC. Explained briefly, the proposal called for a.) the distribution of the duties of normally performed by the ANS Vice President among the members of the ANS EC for the academic year 2023; and b.) the automatic extension of the aforementioned contingency until January 2024, should no suitable candidate(s) be identified for the Vice President post by September 1, 2023, as stipulated in Article IV, Section 1a of the ANS Bylaws. The contingency plan was made in accordance with Article II, Section 1a (4) of the ANS Bylaws. On December 12, 2022, an official tally was made of the ANS EC votes received by the stipulated deadline. The proposal was unanimously carried.

In accordance with Article IV, Section 3a of the ANS Bylaws, the following nominees are "considered elected by proclamation and will be confirmed at the annual meeting."

#### Incoming President of the American Name Society, Dr. Luisa Caiazzo



Luisa Caiazzo (PhD) is Associate Professor of English Linguistics and Translation at the University of Basilicata, Italy. She has authored several publications on institutional discourse, translation, evaluative language around names and co-edited the book *Naming, Identity and Tourism and Shifting Toponymies*. As a member of the EC of the American Name Society, she has been Secretary, Allied Conference Coordinator, and is the current Vice-President.

Anne W. Anderson, Ph.D., is an independent researcher studying semiotics of multimodal text, critical studies of children's and young adult literature, and theories and methods of research and of learning. ## ANS Research Connections

One of the most common questions the American Name Society receives from the general public is "Where can I study onomastics?" In an effort to help the next generation of onomasticians, it was decided to start a new segment in the ANS newsletter. Each issue, space will be given to students who are searching for an established onomastic scholar to serve as a mentor. In this issue, we are featuring two PhD students: Kaomi Taylor and Kristyna Brezinova, who were both interviewed by Iman Nick.

### Kaomi Taylor: A Graduate Student in Search of PhD Supervisor in Onomastics



Hi! Please call me Kaomi (kerˈəʊmi), a name I adapted from the Gaelic name Caoimhe. I've been fascinated by names all my life and recently learned about the study of names and the American Name Society. My interest in onomastics was piqued by a podcast by Dr. I.M. Nick on the Nazi use of names as a tool of oppression, which connected my passion for names with my decades-long professional focus on issues related to social justice.

## Can you briefly describe your academic background?

I earned my bachelor of arts in American Literature with a focus on writing from Middlebury College. A self-designed minor in Computer Science and Ethics blended computer programming and ethical issues surrounding technology. After several years of working in nonprofits and taking a range of classes, I returned to school to earn a master's degree in Public Administration from the Harvard Kennedy School as a young mid-career professional in 2000. During this time I served as a research assistant for Professor Jane Mansbridge, Charles F. Adams Professor of Political Leadership and Democratic Values at the Harvard Kennedy School. Subsequently I spent a semester in a master's program in public policy at Tufts University, which included coursework in quantitative and qualitative statistics. In 2021 I completed a Certificate in Adaptive Leadership at the Harvard Kennedy School. From 2008-2017 I taught graduate and undergraduate classes as a part-time adjunct business school professor, first at Champlain College and then St. Michael's College. Undergraduate courses included Business Ethics, Business and Public Policy, and Strategic Management. On a graduate level I taught Socially Responsible Business.

## Can you offer a short description of the kind of project you would be interested in for your doctoral studies?

I'm eager to contribute to the scholarship about what names and their usage teach us about our world and our values. I am fascinated by questions like "what might studying name-based prejudice teach us about the mutability of prejudice?" and whether academic research would bear out the validity of "namism" as a discrete occurrence versus solely as symptom of other discrimination. On the policy side, I'm curious about probing the differences in how the law protects brand names vs. individual names to tease out how such institutionalized differences may mirror and shape

our societal values. And from a technological angle, I'm interested in correlating the viral names-as-insults trend alongside social media companies' use of automated technology to promote civil discourse, in order to discern how the two may have influenced each other and predict how they may continue to affect our online interactions.

## Kristyna Brezinova: Seeking a Placement as an Exchange Student



#### What is your primary interest in onomastics?

My main interest in onomastics are anthroponyms. The aim of my dissertation is to reveal whether society perceives certain personal names stereotypically (in Czech Republic). The main anthroponymic interest is concentrated on the Roma & Sinti (RS) population. My research aims to find out if there are names that refer to the RS identity and what stereotypical perceptions of majority societies may have about RS communities.

## Can you share a bit about your academic background?

In August 2019, I completed a bachelor's degree in Czech language and literature, German language and literature – with a focus on philology. In August 2021, I graduated from the University of Ostrava, majoring in Czech language and literature, German language and literature, with a focus on teaching at secondary schools. Currently, I am doing a PhD in the Czech language program at my home university. In addition to my native language, I have achieved the C1-C2 level in German and a C1 level in English.

#### How might our ANS members help?

I am looking for an opportunity to participate in an exchange program where I can study onomastics and/or Roma & Sinti culture. Ideally, the program would allow me to study abroad for a month or two in either 2023 or 2024.
